- **2. Roll Call:** Dumas Present, Muir Present, Poniatowski Present, Viers Present, Amboy Absent.
- **3. Approval of Meeting Minutes from July 18, 2024:** Motion by Poniatowski and second by Viers to approve the meeting minutes from July 18, 2024. Ayes Dumas, Muir, Poniatowski, Viers. Motion carried.
- 4. Correspondence Letter from SVSU regarding Board Conflict of Interest Questionnaire. Letter from Mattina, Kent, and Gibbons (scope of audit)

Young reminded the Board that, as part of the annual audit by Mattina, Kent, and Gibbons, each board member is required to complete the Board Conflict of Interest Questionnaire promptly when received. Dumas and Muir have completed as part of their reappointment to the Board in July 2024.

5. Financial Items:

- b. Young provided an enrollment update. The school continues to be at maximum levels for enrollment, adding students for new staff members.
- c. Young also reviewed the School Emergency Operations Plan. There were no changes from the prior year.
- d. Before discussing the HR Board Subcommittee formation, Young and Poniatowski made separate statements related to a 2023 email received by Young concerning the Academy's former music teacher. After the Board discussion regarding this email, Young proposed the establishment of the HR Board Subcommittee to help ensure appropriate oversight over human resource decisions. More details regarding this Subcommittee will be discussed in upcoming board meetings.
- e. New staff members were introduced to the board for the upcoming 2024-25 school year.

7. Chatfield School Directors Report:

a. Kraly provided an update on the upcoming school activities.

8. CMC Directors Report

a. Young stated that there is a review underway of the current structure of the management company. There is no intention of creating a for-profit management company, but instead a review of other academy structures.

9. Public Comment

Several teachers were in attendance and expressed significant concern regarding item 6d above, as before this meeting they were unaware, and understood the directors to be unaware, of any prior allegations against the Academy's former music teacher.
